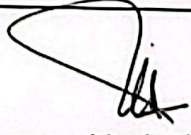

15	The appeals/ objections if any to nomination of candidate may be filed before Election Commission (within 24 hours of candidate list display upto 4:pm)	6-10-2026
16	Last date of decision taken by election commission on objections (within 2 days)	8-10-2026
